<u>Trails Report (Ralph Stewart)</u>: Lack of snow discussed. Best to ride trails. People are going above the trailheads to park. Not enough snow to groom yet.

<u>CSA Report</u>: Ron Spencer reminded us the CSA State Convention is January 22 -24 at Mt. Princeton in Nathrop, CO. Put on by Salida. Contact Ron if you are interested in running for District 2 Rep. (our district). The positions for CSA Vice President and Treasurer are also open. Contact Ron Spencer if you are interesting in running for either of these positions.

**Groomer Report**: (Joe Tonso): The Groomer is ready when we have enough snow. Jimmy Rossi replaced the harness. All fluids are checked and filled, the SPOT satellite transmitter is in the Cab and the groomer was started and ran. Containers for Groomers' personal gear are on and ready. The logbook and chain saw gas are in the groomer. Jimmy Rossi is to check and if needed, repair the groomer chain saw, chain and pull rope. The chain saw needs to be put in a locked area on the groomer.

Dave W. to check with the ATV club to see if we can use any of their 2 new chain saws.

There is a gas stove for heat at the Groomer Barn.

Joe T. reminded all groomers to make sure the groomer is completely fueled up before grooming.

The list of survival gear to be kept in the groomer was read and discussed at the end of the meeting. Groomers decided which equipment was personal and which was to remain in the groomer.

Some gear will need to be purchased.

#### **OLD BUSINESS**

Raffle Ticket sales: (Jenn Tonso) Between members selling tickets on their own and selling at Craig merchants, 1,677 of the 2,000 tickets we had were sold. Total money = \$8,385 was mailed to CSA. We usually get about 40 some % back, which we put towards awarding scholarships for Moffat county students. There was a total of \$133.00 in additional scholarship donations. Joe and Jenn Tonso will not take charge of the raffle ticket sales next year. We need to consider if we will sell raffle tickets next year. <u>CSA Capital Grant:</u> Members are to be thinking what project we might apply for. The project(s) are for physical projects, with club matching funds and club volunteer work. The Grant forms will be out mid March to April and due in May. Normally CSA has a total of \$75,000 - \$80,000 to dispense among Grant applicants. Most Grants are awarded in the \$5,000 range.
